The Employer has executed the Declaration of Trust of the Moraga-Orinda Fire Protection District Integral Part Trust in the form of the sample trust made available by the ICMA Retirement Corporation.

BE IT FURTHER RESOLVED, that the Human Resources Manager shall be the coordinator and contact for the Program and shall receive necessary reports, notices, etc.
