RESOLUTION NO. 22-11

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE MORAGA-ORINDA FIRE PROTECTION DISTRICT OF CONTRA COSTA COUNTY RECOGNIZING THE J & J RANCH AS A SHELTER-IN-PLACE COMMUNITY

WHEREAS, The Moraga-Orinda Fire Protection District contains multiple communities nestled within the wildland urban interface (WUI) areas where wildland vegetation is intermixed with structures. When living within the WUI, planning for wildfires is a necessity, and preparing for wildfires before they happen is the best defense against the flames; and

WHEREAS, J & J Ranch was approved on February 20, 2019 and built with ember-resistant construction-specific standards that allow residents who are unable to evacuate during a wildfire to remain inside their ignition-resistant house until the emergency is over; and

WHEREAS, J & J Ranch has a well-maintained, fire district approved landscape and vegetation management plan, and a Wildfire Hazard Assessment and Plan is in place; and

WHEREAS, J & J Ranch has adequate roadway widths (20' or more) and driveway widths, designed to accommodate two-way traffic and large firefighting apparatus; and

WHEREAS, J & J Ranch has adequate water supply and water flow for firefighting efforts; and

WHEREAS, every home in the J & J Ranch community was built with life-safety residential fire sprinklers, a well-maintained, fire district-approved fire-resistant landscape with a minimum 100-foot defensible space surrounding all structures, a "Class-A," ignition-resistant roof, dual pane (one being tempered) glass windows, and chimneys with spark arrestors containing a minimum ½" screen; and

WHEREAS, the J & J Ranch community is deemed Firewise and remains in good standing; and

WHEREAS, to remain a shelter-in-place community, each of the ember-resistant qualities must be maintained year-round. Additions or changes in landscaping require fire district and association approval.

NOW THEREFORE BE IT RESOLVED that the Board of Directors hereby recognizes the J & J Ranch Subdivision as a Shelter-In-Place community; and

BE IT FURTHER RESOLVED if a wildfire nears the J & J Ranch Subdivision Shelter-In-Place community, that the Board of Directors advises residents to evacuate as the best option.
