

RESOLUTION NO. 22-16

A RESOLUTION OF THE BOARD OF DIRECTORS OF
THE MORAGA-ORINDA FIRE PROTECTION DISTRICT
ESTABLISHING THE APPROPRIATIONS LIMIT FOR
FISCAL YEAR 2022/23 PURSUANT TO ARTICLE XIII B OF
THE CALIFORNIA CONSTITUTION

WHEREAS, Article XIII B of the California Constitution provides that the total annual appropriations subject to limitation of each governmental entity, including the Moraga-Orinda Fire Protection District ("District"), shall not exceed the appropriations limit of such entity of government for the prior year adjusted by certain changes mandated by Proposition Four passed in November, 1979 and Proposition 111 in June, 1990 except as otherwise provided for in Article XIII B and implementing State statutes; and,

WHEREAS, pursuant to Article XIII B, and Section 7900 *et seq.* of the California Government Code, the District is required to set its appropriations limit for each fiscal year; and,

WHEREAS, District Staff conducted necessary analysis and calculations to determine the appropriations limits for fiscal year 2022/23, relying on the prior fiscal year approved limit and using the following two adjustment factors: *Annual Percent Change in Population for the County of Contra Costa in conjunction with Percentage Change in Per Capita Personal Income*; and,

WHEREAS, based on such calculations District Staff has determined the said appropriations limit, and, pursuant to Section 7910 of the Government Code, has made available to the public the documentation used in the determination of the limit;

NOW THEREFORE, BE IT RESOLVED by the District Board of Directors that the Appropriations Limit for Fiscal Year 2022/23 shall be and is hereby set in the amount of \$36,207,281.

PASSED, APPROVED and ADOPTED this 15th day of June, 2022 at a regular meeting of the District Board of Directors held virtually on **June 15, 2022**, on motion made by Director Jorgens seconded by Director Donner and duly carried with the following roll call vote.
