

**RESOLUTION NO. 22-19**

**BEFORE THE BOARD OF DIRECTORS OF THE  
MORAGA-ORINDA FIRE DISTRICT  
CONTRA COSTA COUNTY, STATE OF CALIFORNIA**

**Resolution Ordering Even - Year Board of Directors  
Election; Consolidation of Elections; and  
Specifications of the Election Order**

WHEREAS, California Elections Code requires a general district election be held in each district to choose a successor for each elective officer whose term will expire on the first Friday in December following the election to be held on the first Tuesday after the first Monday in November in each even-numbered year; and

WHEREAS, other elections may be held in whole or in part of the territory of the district and it is to the advantage of the district to consolidate pursuant to Elections Code Section 10400; and

WHEREAS, Elections Code Section 10520 requires each district involved in a general election to reimburse the county for the actual costs incurred by the county elections official in conducting the election for that district; and

WHEREAS, Elections Code Section 13307 requires that before the nominating period opens the district board must determine whether a charge shall be levied against each candidate submitting a candidate's statement to be sent to the voters; may establish the cost; and determine whether the costs be paid in advance; and

WHEREAS, Elections Code Section 12112 requires the election official of the principal county to publish a notice of the election once in a newspaper of general circulation in the District;

NOW, THEREFORE, IT IS ORDERED that an election be held within the territory included in this district on the 8th day of November 2022 for the purpose of electing members to the board of directors of said district in accordance with the following specifications:

**SPECIFICATIONS OF THE ELECTION ORDER**

1. The Election shall be held on Tuesday, the 8th day of November 2022. The purpose of the election is to choose members of the board of directors or councilmembers for the following seats: (offices and terms)

<u>Director Division 1</u>	<u>4-year term</u>
<u>Director Division 3</u>	<u>4-year term</u>
<u>Director Division 4</u>	<u>4-year term</u>

2. The District has determined that the Candidate will pay for the Candidate's Statement. As a condition of having the Candidate's Statement published, the candidate shall pay the estimated costs at the time of filing. The Candidate's Statement will be limited to four hundred (400) words. The District hereby establishes the estimated cost for a candidate statement as the following:

Division 1 - \$500.00

Division 3 - \$500.00

Division 4 - \$500.00

3. The District directs that the County Registrar of Voters of the principal county publish the Notice of Election in a newspaper of general circulation that is regularly circulated in the territory.
4. The District has determined that in the event of a tie vote, the winner shall be determined by lot at a time and place designated by this Board.
5. This Board hereby requests and consents to the consolidation of this election with other elections which may be held in whole or in part of the territory of the district, pursuant to Elections Code 10400.
6. The district will reimburse the county for the actual cost incurred by the county elections official in conducting the general district election upon receipt of a bill stating the amount due as determined by the elections official.
7. The Clerk of this Board is ordered to deliver copies of this Resolution, to the Registrar of Voters, and if applicable, to the Registrar of Voters of any other county in which the election is to be held, and to the Board of Supervisors.
8. THE FOREGOING RESOLUTION WAS ADOPTED upon motion by Director Jorgens, seconded by Director Donner, at a regular meeting of the Board of Directors held virtually on this 15<sup>th</sup> day of June 2022, by the following roll call vote:
