RESOLUTION NO. 22-22

A RESOLUTION OF THE MORAGA-ORINDA FIRE DISTRICT DECLARING THAT FIRE HAZARDS ON 34 LA CAMPANA ROAD, ORINDA, CA, APN: 262191005 CONSTITUTE SEASONAL AND RECURRENT PUBLIC NUISANCES AND DIRECTING THE FIRE CHIEF TO ABATE THESE NUISANCES AT THE PROPERTY OWNER'S EXPENSE

WHEREAS, on July 15, 2020, under the authority of Section 13869 of the California Health and Safety Code, the Moraga-Orinda Fire District adopted Ordinance 20-01 adopting and amending the California Fire Code, 2019 Edition, and by reference, the International Fire Code, 2018 Edition; and

WHEREAS, section 304.1.2 of the Fire Code requires all property owners and occupants in the District to clear their property of weeds, grass, vines, leaves, brush, diseased or dead trees, combustible growth, debris, or rubbish in accordance with the standards set forth in Section 325 of the Fire Code; and

WHEREAS, section 325 of the Fire Code was intended to identify and eliminate fire hazards to decrease frequency and severity of fires that may threaten life, overwhelm fire suppression capabilities, and result in property loss; and

WHEREAS, On September 7, 2021 MOFD staff inspected the property located at 34 La Campana Road, Orinda, CA APN: **262191005** ("the Property") and observed violations of Sections 325.6.2.1, 325.6.2.2, 325.6.3.3, and 325.6.3.1.2 of the Fire Code, which constitute fire hazards; and

WHEREAS, On September 8, 2021 MOFD send a 30-day Exterior Fire Hazard Property Assessment Notice identifying the violations found on the Property; and

WHEREAS, MOFD staff inspected the Property again after the 30-day deadline had elapsed and observed that the violations had not been remedied; and

WHEREAS, On October 15, 2021 MOFD staff sent the Property owner a Notice to Abate alerting the Property owner to the violations, directing the Property owner to remedy the violations within 15 days, and stating that if the Property had to be abated by the MOFD, the cost of the abatement and an administrative fee would be assessed and a lien might be placed on the Property; and

WHEREAS, MOFD subsequently re-inspected the Property and observed no apparent mitigation efforts; and

WHEREAS, On November 4, 2021 MOFD staff sent the Property owner a Pre-Citation letter alerting the Property owner to the violations, directing the Property owner to remedy the violations within 15 days, and stating that failure to comply with the Fire Code may result in the issuance of additional citations and increasing fines; and

WHEREAS, MOFD subsequently re-inspected the Property and observed that some mitigation efforts had been made, but that the violations had not been remedied; and

WHEREAS, on April 21, 2022 MOFD staff sent the specified property owner an Administrative Citation for failure to comply with the Fire Code and imposed a \$100 fine; and

WHEREAS, MOFD subsequently re-inspected the Property and observed that a few mitigation efforts had apparently been made, but that the violations had not been remedied; and

WHEREAS, On May 19, 2022 MOFD staff sent the Property owner a second Administrative Citation for failure to comply with the Fire Code and imposed a \$200 fine; and

WHEREAS, MOFD subsequently re-inspected the Property and observed no apparent mitigation efforts; and

WHEREAS, On June 2, 2022, MOFD staff sent a Pre-Lien notification letter notifying the Property owner that the District would be moving forward with an abatement hearing; and

WHEREAS, MOFD staff mailed the Property owner an Abatement Hearing Notification letter on June 23, 2022, stating that the MOFD Board was preparing to process the Property for abatement by the District and that the Board would hold an Abatement hearing on July 20, 2022; and

WHEREAS, on June 30, 2022, MOFD staff re-inspected the Property and determined that the Fire Code violations were still present on the Property; and

NOW, THEREFORE, BE IT RESOLVED that the Moraga-Orinda Fire District hereby finds and declares that the fire hazards existing on the Property, as set forth in "Exhibit A" attached hereto and made a part hereof, constitute seasonal and recurrent public nuisances; and be it

FURTHER RESOLVED that the Chief of the Moraga-Orinda Fire District is directed to abate the nuisances on the Property; and be it.

FURTHER RESOLVED that the Chief shall keep a record of the costs of abating the nuisance on the Property, and those costs, including an administrative fee and attorney's fees, may constitute a special assessment against the Property and a lien on the Property; and be it

FURTHER RESOLVED that the project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15304 (Minor Alterations to Land) for fuel management activities within 100 feet of a structure.

Abatement of hazardous vegetation and combustible material to mitigate the likelihood of dangerous wildfires requires a joint effort from all property owners within the jurisdiction of the Moraga-Orinda Fire District ("MOFD"). The goal of our fire prevention program is to educate and provide guidance regarding how to create and maintain defensible space around structures in compliance with applicable state and local law.
